

YOUR HOA AT WORK!

Your HOA has been busy working to address areas that are meaningful to you. Below is a summary of our progress so far!

BEAVER DAMAGE AND DRAINAGE ISSUES

The HOA is currently receiving quotes for trapping the beavers and removing the den. This should address some of the drainage issues we have been experiencing in the neighborhood. We hope to have this addressed in the next few weeks.

ISSUES WITH COMMUNITY ENTRANCE ON SHAWNEE

On March 20th, 2023, members of the HOA Team met with Ellis County Commissioner, Kyle Butler and the owner of the metal recycling business. Ellis county has plans to repave Shawnee around June or July of this year. We had discussions about modifications that could be made to prevent the trucks from driving over our grass. The metal business has indicated a willingness to help in anyway with this project.

We are also in communication with Ellis county regarding the speeds on Shawnee and visibility issues with overgrown trees. We have reached out regarding fixing the speed signs in the community. We will share more as details become available.

Ryan, on behalf of the HOA, submitted a request to the Red Oak postmaster to consider shifting the mailboxes to the other side of the road. We will keep you updated as more information becomes available.

SPECTRUM FIBER INTERNET

The HOA team is currently in communication with Spectrum internet regarding the possibility of bringing fiber internet to Springfield Lakes. The conversation is in its early stages so we will share more information as it becomes available.
